Information:

The Fairpark Family Learning Center provides space for the community to access computer services, Health and Wellness, Digital and Financial Literacy classes and workshops. The Technology Center offers free resources to the community including internet access, office applications, job search assistance, general computer assistance, scanning, email access and printing.

The Fairpark Family Learning Center is open to the public Monday - Friday, 9am - 8pm. Between the hours of 9am - 3pm and 4pm - 8pm, the Technology Center is an active work room. During these hours patrons are expected to utilize facility services for job searches, scanning, printing, and receiving tech help.

From 3 - 4pm patrons may use the Technology Center recreationally for playing video games, watching YouTube videos and listening to music on computers. These activities will not be permitted in the Technology Center outside of the 3-4pm time period.

Free Classes and Workshops:

Love and Logic Parenting *dinner provided

Love and Logic Parenting classes provide tools and strategies to create healthy relationships between children and parents.

Money Smart for Adults *dinner provided

Money Smart basic finance courses will give participants practical knowledge, skill building opportunities and resources that can help manage their finances. Classes will be taught on 14 different modules about various topics.

Digital Literacy for Adults

We have a variety of digital literacy classes taught at our center. Classes include: Basic Computer Skills, Internet Basics, Using Email, Windows 10 & 11, Mac Os (operating system), Intro to Microsoft Word, Intro to Microsoft Excel, Intro to Microsoft PowerPoint, and Intro to Google Docs.

Workshops

Occasionally we will teach shorter classes in the form of workshops. These workshops will cover topics related to our longer class series like basic finance topics, digital literacy topics, and family health and wellbeing topics.
