# **ARPA** Community Grants

In March 2021, the U.S. Government passed the American Rescue Plan Act (ARPA), which supports state and local recovery from the COVID-19 public health emergency. ARPA funding provides assistance to small businesses, nonprofits, and industries such as tourism, travel, and hospitality that were impacted by the pandemic. The Salt Lake City Department of Economic Development created a Community Grant Program to disburse \$2M of the ARPA funds, which provided limited, one-time financial assistance to eligible small businesses, artists, artisans, creative workers, and nonprofits in Salt Lake City that were negatively impacted by the COVID-19 pandemic or related shutdowns.

The funding received by successful applicants helped them promote, expand, and provide their services in a more stabilized environment. Doors were kept open, new performances and contracts were created, updated equipment was purchased, and these businesses continue to add to the rich culture and vibrancy that is Salt Lake City.

### **Arts Council**

This year, the Salt Lake City Arts Council was honored as one of eight cities nationwide to receive a \$1 million Public Art Challenge Grant from Bloomberg Philanthropies. The City's winning proposal, Wake the Great Salt Lake, will feature temporary public artworks by local and regional artists addressing the ecological challenges of the shrinking lake.

Other notable Public Art projects from the year include the installation of Day Christensen's Apricot in the Marmalade District, as well as initiatives supporting emerging public artists like the Foothills Trailhead Bike Rack Mural project and Sidewalk Poetry: Sense of Salt Lake. The Salt Lake Twilight Concert Series, recognized as the "Best Concert Series" by City Weekly, achieved record-setting attendance with over 43,000 attendees last year. Similarly, the Living Traditions festival celebrated its 38th year welcoming nearly 34,000 visitors to experience diverse cultural performances, food, and crafts.

Finally, the Arts Council reaffirmed its commitment to local artists and arts organizations by distributing over \$380,000 through various grant programs in all seven City Council districts, reinforcing the city's commitment to artistic growth and community engagement.



# **Business Development**



Over the past year, the Business Development Division focused its support on the small business community while also working to attract major investment from impactful projects. The demand for small business financing remained steady, and the Economic Development Loan Fund supported five new loans to small businesses totaling \$1M that will anchor our vibrant and bustling neighborhoods. As major road reconstruction projects continued into heavier commercial corridors throughout Salt Lake, the team increased outreach and engagement with impacted small businesses and distributed approximately \$700,000 in grants. The Division supported a surge of capital investment in advanced manufacturing to Salt Lake City's Westside, assisting companies with zoning and permitting.

The Business Development Division continues to work on major initiatives that catalyze important corridors of Salt Lake City, while also highlighting well-regarded but lesser-known ones. The Division completed a conceptual design study for a pedestrian promenade on Main Street, which aims to limit vehicular traffic and provide more opportunities for commerce, arts, and recreation in the heart of Salt Lake City's downtown core. As part of the celebration for National Small Business Week, the Division hosted a Commerce and Culture event that brought community partners and small business owners on food tours in Districts 1 and 7, featuring Salt Lake City's unique, diverse business community.

# Tech Lake City + Workforce Development

Tech Lake City aims to position Salt Lake City as the premier place for technology and innovation, spanning many sectors including life sciences, biotech, fintech, software, aerospace, and renewable energy. According to a November 2023 Kem C. Gardner report, there are 1,600 life sciences companies in Utah, the majority in Salt Lake City. The life science industry contributes \$21.5 billion in revenue to the state's GDP and pays 48% higher salaries on average. Salt Lake City is committed to working upstream to spark interest in these career paths in the K-12 education space and to foster continued interaction and pathways for students to get there. Connecting Salt Lakers to these advanced skills builds economic resilience and gives the city a globally competitive edge.

An event that continues to support this strategy is Human Innovation Day. This is an annual STEM-focused event where Salt Lake students are introduced to the thriving Healthcare Innovation industry careers, internships, and opportunities. This year, 46 students toured ARUP Laboratories and Recursion at the event. They also participated in a question-and-answer session with professionals, including our own technology and innovation advisor, graduate and undergraduate students in the life sciences.



# **Sister Cities**

This past year was a time of revitalization for Salt Lake City's Sister Cities program. In July 2023, Salt Lake City and the Sister Cities board organized a successful visit with a delegation from Salt Lake's oldest sister city, Matsumoto, Japan, from which various economic and cultural exchange opportunities can flourish. Progress was made on preparing a training event for firefighters in the Sister City of Trujillo, Peru, and new and promising opportunities for exchanges with Torino, Italy, are in the works, along with efforts at reconnecting with Chernivtsi, Ukraine; Keelung, Taiwan; and Izhevsk, Russia. The Board and Economic Development staff are hard at work developing specific protocols for fostering clear and genuine communications with Sister City counterparts and other international dignitaries, the Board bylaws were updated, and a process to receive and review requests for new Sister City partnerships is in the works.

As Salt Lake City moves closer to "welcoming the world" again as the host city for the 2034 Winter Olympic Games, the city's flagship diplomacy program, Sister Cities, stands ready to support the City's leadership with the exciting prospect of cultivating the City into an international center for the Winter Olympics and beyond.
